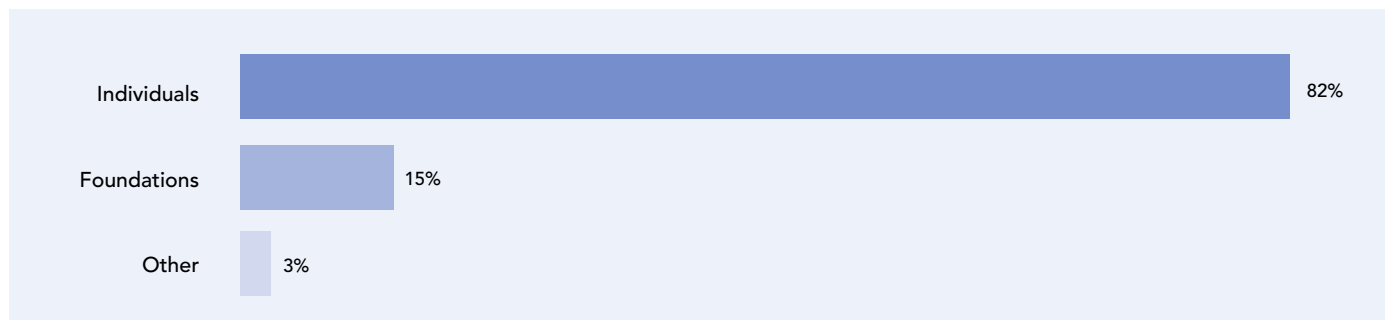
- Improved website navigation which will make it easier to find information;

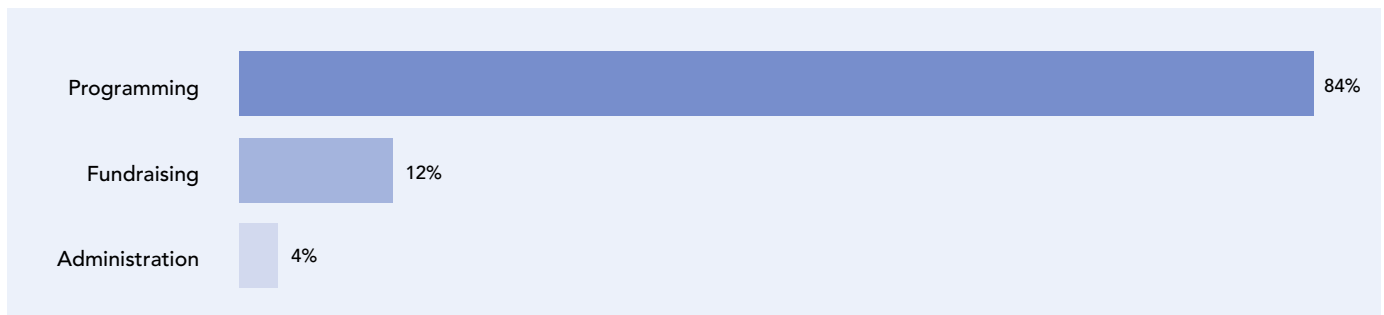
